Partnership for Public Service statement urging the Senate Judiciary Committee to quickly approve the nomination of deputy attorney general-designate Lisa Monaco

WASHINGTON – The nonpartisan, nonprofit [Partnership for Public Service](https://www.partnershipforpublicservice.org) released the following statement from President and CEO Max Stier after the Senate Judiciary Committee hearing on Lisa Monaco’s nomination to be deputy attorney general.

“Lisa Monaco’s public service career in national security and law enforcement is exemplary, making her an excellent choice to be deputy attorney general,” **said Max Stier, president and CEO of the Partnership for Public Service.** “I applaud her dedication to public service, her commitment to uphold the rule of law and her strong support of the department’s professional career workforce.”

Stier continued, “I urge the Judiciary Committee and the full Senate to advance Monaco’s nomination so that she can begin addressing a wide array of pressing issues, including domestic terrorism, criminal justice reform, cybersecurity threats and voting rights.”

The Partnership for Public Service’s [Department of Justice oversight snapshot](#) provides a wide array of data and insights regarding the department. Some key data points include:

- Number of employees: 110,887 (as of March 2019)
- 2019 Best Places to Work in the Federal Government score and rank: 61.4 out of 100, ranking 12th out of 17 large agencies
- Employee confidence in whistleblower protections: 63.2%, which is 1.3 percent lower than the government-wide score of 64.5%
- Number of positions requiring Senate confirmation: [30](#)
