WASHINGTON – The nonpartisan, nonprofit [Partnership for Public Service](https://www.partnershipforpublicservice.org/) released the following statement from President and CEO Max Stier on the nomination of David Uejio to be assistant secretary for Fair Housing and Equal Opportunity at the Department of Housing and Urban Development.

The Partnership for Public Service’s [Department of Housing and Urban Development 2020 Best Places to Work in the Federal Government rankings](https://www.partnershipforpublicservice.org/department-of-housing-and-urban-development-2020-best-places-to-work-in-the-federal-government-rankings) released on Tuesday provide an array of data and insights regarding the agency. Some key data points include:

- Number of employees: 7,734
- 2020 Best Places to Work in the Federal Government score and rank: 71.3 out of 100, ranking 14th out of 25 midsize agencies.
- Rank for responding to employee needs during the COVID-19 pandemic: 12th out of 25 midsize agencies.
